- I. Call to Order: Mr. Rutherford called the meeting to order at 10:09 a.m.
- II. Minutes: The minutes of the meeting held August 21, 2007 were presented for approval. A motion was made by Mr. Doldo to approve the minutes as presented, seconded by Mr. Juravich. All in favor. Carried.
- III. Treasurer's Report: Mr. Fayle reviewed the financial statements for the periods ending August 31, 2007 & September 30, 2007. A motion was made by Mr. Doldo to approve the financial statements as presented, seconded by Mr. Darling. All in favor. Carried.

# IV. Correspondence:

### Fireman's Fund Recommendations -

Mr. Soluri provided a summary of the Fireman's Fund recommendations. Mr. Doldo questioned #6 on the recommendation and ensuring that if WICLDC does not comply are we insured. Mr. Soluri spoke with Keith Caughlin about the situation. Mr. Caughlin made it clear that the WICLDC and JCIDA are not liable for any damage done to the vehicle.
