# For PAAA Reporting Requirements

The mission of the Watertown Industrial Center Local Development Corporation (WICLDC) is to facilitate job creation and retention in the community by providing eligible businesses with suitable leased facilities at rents and under conditions that help them succeed.

The following information is intended to highlight some of the activities for Fiscal Year 2016 – 2017.

### Watertown Center for Business and Industry Capital Projects:

- Completed a 1,500 sq.ft expansion for Pic N Go Waste Services, a startup waste management company with 4 employees. The cost of the project was \$7,513.00. The tenant entered into a 3 year lease, and was approved for a 3 year LHI Loan to cover the cost of the expansion project.
- Repaired the exterior of Building. D, South Side of the building to prevent the exterior wall from failing. This repair allows the WIC and the Tenant a little more time while they work out the details of relocating to Building A. Cost of the project was \$7,799.00.
- Relocated approximately 120 feet of Copper Waterline in Building B to accommodate the height requirements for a new tenant that specializes in moving and warehousing needs of the Government. Cost of the project was \$6,623.00.
- Upgraded the common loading dock for building B, by installing a dock leveler and replacing the bumpers. Cost of the project was \$6.006.00
- Moved approximately \$18,027.00 of work in process into operation.

# Watertown Center for Business and Industry General Notes:

• The WICLDC submitted a CFA with New York State Empire Development to assist with the construction of a new 44,000 square feet warehouse for a local manufacturer. The WICLDC was successful in obtained up to \$400,000 to go towards the \$2.2 million dollar project. The WICLDC and the prospect have modified the project from a new warehouse to a interior renovation project of approximately 34,000 sq.ft, this will allow the tenant to move forward with the project. Empire State has approved of the grant modification and reduced the award to \$60,000.00.
