- Completed the Infrastructure Project Expenses relating to this project during the fiscal year ending 6-30-25 were \$299,942 Total cost of the project was \$324,691. Project was completed at the end of June 2025.
- Completed the Brookfield Power Restroom Renovation project Expenses relating to this
 project during the fiscal year ending 6-30-25 were \$149,412. Total cost of the project was
 \$177,919. Project was completed at the end of June 2025.
- Over \$500.000 was capitalized due to the completion of projects.

Watertown Center for Business and Industry General Notes:

• The agency utilized the entire ARPA award of \$290,000 to cover expenses relating to the infrastructure project.
